WARRANT AND COVENANT THAT:

1. I am the owner / rider of the Quad recreational motorcycle described in the schedule ('the quad')

ACKNOWLEDGEMENT OF RISKS AND OBLIGATIONS

1. I acknowledge that quad riding could be a dangerous sport and that by engaging in this sport in any location I could be exposed to certain risks and dangers and accept those risks and dangers these including (but not limited to):

- a) that I may be injured, physically or mentally or may be killed; b) that my quad and any personal possession, equipment and clothing may be damaged, lost or destroyed;
- c) that other riders may ride dangerously or with a lack of skill;
- d) that land and weather conditions may be hazardous and may vary without warning or predictability;
- e) any area that I ride in may be dangerous or a difficult riding environment;
- f) that there may be no or inadequate facilities for medical treatment or the transporting of me to a hospital or treatment facility if I am injured;
- g) that I have an obligation to myself and others to ride my quad and any other quad safely and within my capabilities without causing any danger or harm to any other rider;

2. I acknowledge that I am riding my quad or any other quad at my sole risk and responsibility.

3. I acknowledge that if I ride my quad or any other quad outside of private property on Crown Land or in State Forest I do so of my own free will and I made the conscious decision to leave private property.

4. I acknowledge that I am presumed to know the property boundaries and when private property becomes Crown Land.

5. I am aware that the QRCV does not support or in any way promote riding of quads outside private property.

6. I agree that I will not hold the QRCV or any of its committee or the promoter, advertiser club sponsor or organiser of any event liable for my death, or injury or damage caused by me riding my quad or any other quad in any place.

INDEMNITY

By the signing of this document I agree to indemnify the QRCV or any of it's committee or promoters, sponsors, advertiser or organiser of any event, against any and all actions or claims which may be made by me or on my behalf by any other parties for or in respect of, or arising out of death or any injury to me or my family, loss or damage caused or suffered to me or my family or quads, equipment, possessions and clothing, whether caused by any negligence or in any other manner whatsoever whilst riding my/our quad/s or any other quad in any place.
